- The project must further the purpose of increasing membership, and/or provide a new service and/or improve the quality of current service

OYSAN Recreational Grant
Request for Proposal

Grants totaling \$5,000 will be made for the purpose of enhancing recreational soccer clubs and leagues. Any league or club currently affiliated with the Ohio Youth Soccer Association North may apply for a grant. Due to the limited nature of the grant monies available, the grants are designed to be small and no grant amount over \$2,000 will be awarded. It is anticipated that most grants will be in the \$500 range, and can consist of certificates, cash or in-kind services.

The grant amount must be no more than 50% of the cost of the total project. The club/league requesting a grant must be in good standing with OYSAN. A grant from OYSAN would be a one-time occurrence and will be given in one amount.

To be successful, the grant must be on the forms provided, must be for the exclusive use of recreational programs and players, and must further the purposes of increasing membership, proving a new service or improve the quality of current service.

The following are ideas for grant topics, but are, by no means, the only ideas that may be successful: outreach to schools to increase membership, setting up a play day or tournament, long-range-planning process, player/coach handbook, financial software, league contribution for OYSAN Referee Mentoring program, startup newsletter costs, training equipment, play day at the beginning or end of the season, coaching director education, web page development, computer, software, etc.

The OYSAN forms have to be submitted. Grant Applications are due by 4:00 PM on September 24, 2010. All grants will be awarded on November 13, 2010 at the OYSAN AGM Awards Luncheon. **Leagues who are awarded with a grant must have someone at the AGM Luncheon to receive the grant award. If no one is present, the grant award is forfeited.** The application is now available on the OYSAN web page at www.OYSAN.org, Programs on the menu. Grants must be typed or neatly written.

A budget indicating exact anticipated expenditure of the monies must be submitted. Any attempt to use the grant funds inappropriately will place the league or club in bad standing with OYSAN. A league or club with more than one level of play must certify that the funds are to be used totally to benefit only recreational players.

The decision on grant winners of the OYSAN is final. No record of deliberations will be made. All questions about the grant process must be made to the OYSAN Executive Director, Tom Faro.

All information must be listed, all documents attached, and the package is considered complete as issued. No add-on documents will be accepted. Only one request per league/club will be accepted.

The person completing the application may or may not be called for clarification of an item or items, but no additional materials may be issued.

The OYSAN Executive Director will recommend disbursement of grants to the Board of Directors who will make the final grants including amounts. Both the Executive Director and the Board of Directors reserve the right to present all or part of the amount marked for disbursement and the total may not reach the amount requested either in total for the grant request or for the amount available.
