General Policies

- Facility may be used only by SRC affiliated groups or organizations for scheduled activities and practices.
- The Facility will be open from dawn to ½ hour past sunset unless events are scheduled through Sylvania Recreation.
- **Coolers** are not permitted inside the facility.
- **Moving/modifying any sports equipment** is strictly prohibited
- **Camping** is not permitted
- **Off-Road Vehicles** are not permitted
- **Alcohol** is not permitted
- **Grills or cookers** are not permitted on the premises.
- **Pop up tents** are not permitted unless approval has been received from Sylvania Recreation.
- **Pets** are not allowed on the playing areas.
- **Golfing** is not allowed on any areas at Pacesetter Park
- **Smoking** is not permitted in any game areas. Smoking is allowed in the parking lot areas only.
- **Soliciting** is not permitted
- **Foul Language** is not permitted by players or spectators. If you are found breaking this policy you may be asked to leave the facility and or league temporarily or permanently.

Weather Related Policies

- **Lightning Detection System** -This system is designed for park patron's safety. When the siren sounds at a solid continuous tone, all activities must be suspended and patrons need to seek shelter immediately. When the danger clears the area, an all-clear siren will sound a Hi-Lo tone and activities can resume.
- **Lightning Light** – A yellow warning light, located on top of the maintenance building will remain flashing while there is a danger of lightning in the area.
- **Red & Green Flag** – Located at the entrance to the park, a flagpole will have either a red or green flag flying. The GREEN flag means the park is open and the Red flag signifies the park is closed. No activities can take place in the park when it is closed.
- **Closure signage** – A closure sign will be posted along the entrance to the park notifying park patrons of closures or cancellations. This information can also be found on the electronic sign located on the main entrance form Sylvania-Metamora Rd.
- **Weather Line** -Sylvania Recreation has set up a weather line in which patron's can call in order to find out if the field closures or cancellations. That number is 419-882-1500 x 506. Messages will be updated on a regular basis when severe weather conditions exist.
- **Tornado Siren** - If the tornado siren sounds, all games and practices MUST be suspended and you must seek shelter or leave the park. NO ONE is allowed to remain out in the park. Shelter area at the park is limited.

Baseball & Softball

- Hitting baseball/softballs into the chain link fence is strictly PROHIBITED.
- Trash and equipment must be removed from dugouts by the team after each game.
- Scoreboards and P.A. system can be used only if the host has a designated supervisor (must be 16yrs. old) in charge during all hours of the event. When the system is used only those people keeping score are permitted in the booth. No one under the age of 16 is permitted in the booth. The user or host accepts ALL responsibility for any damage or missing equipment that occurred during their event.
- Ball field lights are to be turned on only by a Sylvania Recreation representative only.
- Only Sylvania Recreation vehicles permitted between the ball fields at any time.
- Bases and pitchers rubbers are to be moved only by Sylvania Recreation representatives.
- If frost exists on the fields, games or events will be delayed until a Sylvania Recreation representative approves the start of the event.
- Sylvania Recreation will make all decisions on field playability due to inclement weather or unsafe field conditions.

Grass Sports

- Moving goals or other sports equipment is strictly prohibited
- All personal sports equipment brought to this facility for practices must be removed after each use.
- Only Sylvania Recreation can maintain painted lines on soccer fields at the Pacesetter Park. Painting of lines for any purpose by users is strictly prohibited
- Camps and try-outs must alternate areas of use daily as to not cause excessive wear to the turf areas.
- Only Sylvania Recreation vehicles are permitted on the fields at any time unless approval has been received from Sylvania Recreation.
- If frost exists on the fields, Games or events will be delayed until a Sylvania Recreation representative approves the start of the event.
- User groups or hosts are responsible for picking up loose trash on the fields or areas adjacent to the fields.
- Sylvania Recreation will make all decisions on field playability due to inclement weather or unsafe field conditions

Sylvania Recreation Corporation by its Sylvania Recreation Corporation Board of Directors has established these rules for all persons and groups that use the facility and requires them to be followed by all Pacesetter Park users. Sylvania Recreation Corporation Board of Directors may alter, change and add any rules they deem necessary to provide the public and all citizens of the Sylvania area a high quality facility and to protect the public. Failure to follow these rules or any rule a Sylvania Recreation Corporation Officer or its Board of Directors deem appropriate for a particular situation of which the user had prior knowledge could result in:

- Revoking of permit for that group
- The host/user group will be held financially responsible for damages
- The host/user group may lose the use of Sylvania Recreation facilities
